A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GYPSUM, COLORADO, APPOINTING THE INTERIM TOWN CLERK, TOWN TREASURER, TOWN ATTORNEY, INTERIM MUNICIPAL COURT CLERK, WATER ATTORNEY AND WATER ENGINEER.

WHEREAS, the Town of Gypsum, Colorado (“Town”), is a home rule municipality duly organized and existing under Article XX of the Colorado Constitution and the Town’s Home Rule Charter effective October 21, 1982; and

WHEREAS, the members of the Town Council (“Council”) have been duly elected, chosen and qualified; and

WHEREAS, Article V, Section 5.3 of the Gypsum Town Charter requires the Town Council appoint a Town Clerk, who may also serve as Town Treasurer, who shall be custodian of the Town seal and who shall keep a journal of Council proceedings and record in full all ordinances, motions and resolutions; and

WHEREAS, Article V, Section 5.3 of the Gypsum Town Charter requires the Town Council appoint a Town Treasurer, who may also serve as Town Clerk, who shall have charge of the financial records of the Town and shall collect, receive and disburse all monies belonging to the Town and shall have all other duties required to administer properly the financial affairs of the Town; and

WHEREAS, Article IX, Section 9.1 of the Gypsum Town Charter requires the Town Council appoint an attorney for the Town licensed to practice law in the State of Colorado; and


WHEREAS, Title 2, Section 2.01.130 of the Gypsum Municipal Code requires the Town Council appoint a Municipal Court Clerk, whose duties shall be those assigned by the presiding Municipal Judge and local rules.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GYPSUM, COLORADO AS FOLLOWS:


1. Lily Ludwig is hereby appointed as the interim Town Clerk of the Town of Gypsum pursuant to Article V, Section 5.3 of the Gypsum Town Charter.
2. Mark Silverthorn is hereby appointed as the Town Treasurer of the Town of Gypsum pursuant to Article V, Section 5.3 of the Gypsum Town Charter.
3. Collins, Cockrel & Cole, P.C. are hereby appointed as the Town Attorneys of the Town of Gypsum and
4. Patrick, Miller & Noto are hereby appointed as the Town Attorneys for water-related matters pursuant to Article IX, Section 9.1 of the Gypsum Town Charter.
5. Valorie Nelson is hereby appointed as the interim Municipal Court Clerk of the Town of Gypsum pursuant to Title 2, Section 2.01.130 of the Gypsum Municipal Code.
6. Zancanella & Associates is hereby appointed as the engineers for water related services for the Town of Gypsum.

This Resolution was introduced, read and adopted upon a motion duly made, seconded and passed this 12 day of January 2021 by a vote of 7 in favor and 0 against.
