RESOLUTION NO. 22 (SERIES 2022)

A RESOLUTION AUTHORIZING CERTIFICATION OF DELINQUENT CHARGES AND ASSESSMENTS FOR COLLECTION BY THE EAGLE COUNTY TREASURER

WHEREAS, the Town of Gypsum, Colorado ("Town"), is a home rule municipality of the State of Colorado, duly organized and existing under Article XX of the Colorado Constitution and the Gypsum Home Rule Charter effective October 21, 1982; and

WHEREAS, the Town of Gypsum is empowered by Section 31-20-105, C.R.S., and by Sections 3.16.040 and 8.05.030(2) of the Town's Municipal Code to collect delinquent charges and assessments by certification to the Eagle County Treasurer; and

WHEREAS, proper notice of this public meeting was mailed to the property owners and affected properties.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GYPSUM, COLORADO:

- Section 1. <u>Certification</u>. The Town of Gypsum certifies to the Eagle County Treasurer that the amounts listed on Exhibit A attached hereto are fees, penalties, charges or assessments levied for outstanding charges to the Town of Gypsum and that bills for such amounts were presented and that over thirty (30) days have passed since the time of presentment of such bills.
- Section 2. Request for Collection. The Town requests that the Eagle County Treasurer collect these delinquent amounts at the earliest possible date in the same manner as property taxes and pursuant to Section 31-20-106, C.R.S., and add to such amounts an additional penalty to be paid by the property owners or affected part to defray the cost of collection.
- Section 3. <u>Severability</u>. If any part, section, subsection, clause or phrase of this Resolution is for any reason held to be invalid, such shall not affect the validity of the remaining provisions.
- Section 4 <u>Effective Date</u>. This Resolution shall take effect and be enforced immediately upon its approval by the Town Council.
