**AN ORDINANCE LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 2021, TO
DEFRAY THE COST OF GOVERNMENT FOR THE TOWN OF GYPSUM,
COLORADO, FOR THE 2022 BUDGET YEAR.**

WHEREAS, The Town Council of the Town of Gypsum will adopt the annual budget in accordance with the local government budget law, on the 13th day of December, 2022, and;

WHEREAS, the 2023 valuation for assessment for the Town of Gypsum, as certified by the County Assessor, is \$184,358,910.

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GYPSUM, COLORADO:

THAT, for the purpose of meeting all general operation expenses of the Town of Gypsum during the 2022 Budget Year, there is hereby levied a tax of 5.094 mills upon each dollar of total valuation for assessment of all taxable property within the Town of Gypsum, as hereinabove determined and set, and;

A public hearing of this Ordinance shall be held on the 13th day of December 2022, at 7:00 p.m. at the Gypsum Town Hall; 50 Lundgren Boulevard, Gypsum, Colorado.

INTRODUCED, READ AND ORDERED PUBLISHED by the Town Council of the Town of Gypsum, Colorado, at its regular meeting held at the Gypsum Town Hall, on November 8, 2022.

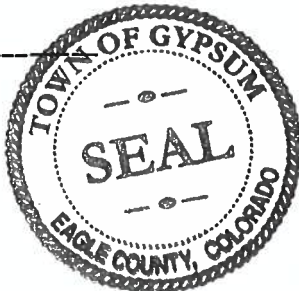


