
CERTIFICATE OF PUBLICATION

TOWN OF GYPSUM, COLORADO ORDINANCE 13 SERIES 2022

AN ORDINANCE TO TRANSFER UNENCUMBERED APPROPRIATIONS OF THE TOWN OF GYPSUM, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2022, AND ENDING ON THE LAST DAY OF DECEMBER, 2022.

WHEREAS, the Town of Gypsum, Colorado ("Town"), is a home rule municipality duly organized and existing under Article XX of the Colorado Constitution and the Town's Home Rule Charter effective October 21, 1982; and

WHEREAS, the members of the Town Council ("Council") have been duly elected, chosen and qualified; and

WHEREAS, Council appropriated funds for the fiscal year 2022 as follows:

Sewer Fund \$3,741,795 American Rescue Plan \$0

WHEREAS, the necessity has arisen for additional expenditures in the American Rescue Plan requiring the expenditure of funds in excess of those appropriated for the fiscal year 2022 and

WHEREAS, the unanticipated additional expenditures are contingencies which could not have been reasonably foreseen at the time of adoption of the budget; and

WHEREAS, funds are available for such expenditures from unanticipated revenue and/or surplus funds in the respective funds.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GYPSUM, COLORADO, that:

The Budget expenditures for the fiscal year 2022 of the Town of Gypsum, Colorado, shall be and hereby are amended as follows:

Sewer Fund \$2,991,795 American Rescue Plan \$750,000

SECTION 2 - APPROPRIATION. Such sums are hereby appropriated from the revenues of the Town to the proper funds for the purposes stated.

<u>SECTION 3 - PUBLIC HEARING</u> A public hearing on this Ordinance shall be held on the 8th day of November 2022 at 7:00 p.m. at the Gypsum Town Hall, 50 Lundgren Boulevard, Gypsum, Colorado.

<u>SECTION 4 - EFFECTIVE DATE</u>. This Ordinance shall become effective as a permanent Ordinance five days after publication following final passage.

<u>SECTION 5 - SEVERABILITY</u>. If any portion of this Ordinance is found to be void or ineffective, it shall be deemed severed from this Ordinance and the remaining provisions shall remain valid and in full force and effect.
