AN ORDINANCE OF THE TOWN OF GYPSUM, COLORADO AMENDING PORTIONS OF THE ZONING CODE, TITLE 18, OF THE GYPSUM MUNICIPAL CODE, CHAPTER 18.06 TABLE OF USES-NONRESIDENTIAL ZONE DISTRICTS,

WHEREAS, the Town of Gypsum, Colorado ("Town"), is a home rule municipality of the State of Colorado, duly organized and existing under Article XX of the Colorado Constitution and the Gypsum Home Rule Charter effective October 21, 1982; and

WHEREAS, pursuant to Article 1.3 of the Charter, the Town has all power of local self-government and home rule and all power possible for a home rule municipality to have under the Constitution and laws of the State of Colorado; and

WHEREAS, pursuant to Article 8.2 of the Charter, the Town Council has the power by ordinance to limit the use of private property without the consent of the owner; and

WHEREAS, the Town Council has, by Ordinance, adopted Title 18 of the Gypsum Municipal Code ("Code") regarding zoning ("Zoning Code"); and

WHEREAS, the town staff discovered missing sections of Chapter 18.06 that had previously been adopted by the Town Council with Ordinance No. 06 (Series 2019); and

WHEREAS, the Town Council hereby finds and determines that amending the Zoning Code is appropriate and necessary to the function and operation of the Town.

NOW, THEREFORE, be it ordained by the Town Council of the Town of Gypsum, Colorado that:

- <u>Section 1.</u> Amendment of Section 18,06.010. Section 18.06.010 is hereby amended to include Hostel in the Interstate Commercial district as Not Permitted____ and Intermediate Health Care Facility in the Market District as Not Permitted; as demonstrated in Exhibit A.
- <u>Section 2.</u> <u>Public Inspection</u>. Copies of this Ordinance, the Official Zone Map, and the Gypsum Municipal Code are available for public inspection at the office of the Gypsum Town Clerk.
- Section 3. Public Hearing. A public hearing on this Ordinance shall be held on the 13th day of July, 2021 at 7:00 p.m. at the Town of Gypsum Town Hall, 50 Lundgren Boulevard, Gypsum, Colorado.

Effective Date. This Ordinance shall become effective as a permanent Ordinance five (5) days after publication, following final adoption after a public hearing held on the 13th day of July, 2021, at 7:00 p.m., at the Gypsum Town Hall, 50 Lundgren Boulevard, Gypsum, Colorado.

Severability. If any part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.
