AN ORDINANCE OF THE TOWN OF GYPSUM, COLORADO REPEALING AND READOPTING SECTION 17.20.070(A)(D)(3) AND 17.70.010, OF THE GYPSUM MUNICIPAL CODE, REGARDING ADMINISTRATIVE REVIEW OF FINAL PLAT AMENDMENTS

WHEREAS, the Town of Gypsum, Colorado ("Town"), is a home rule municipality of the State of Colorado, duly organized and existing under Article XX of the Colorado Constitution and the Gypsum Home Rule Charter effective October 21, 1982; and

WHEREAS, pursuant to Article 1.3 of the Charter, the Town has all power of local self-government and home rule and all power possible for a home rule municipality to have under the Constitution and laws of the State of Colorado; and

WHEREAS, the Town Council has, by Ordinance, adopted Title 17 of the Gypsum Municipal Code ("Code") regarding subdivision of land ("Subdivision Code"); and

WHEREAS, the Town Council hereby finds and determines that amending the Subdivision Code is appropriate and necessary to the function and operation of the Town.

NOW, THEREFORE, be it ordained by the Town Council of the Town of Gypsum, Colorado that:

- Section 1. Repeal and Readoption of Section 17.20.070(a)(3)(d). Section 17.20.070(a)(3)(d) is hereby repealed and readopted as shown below and incorporated herein.
 - d. *Notice*. No public notice is required for administrative plats subdividing previously approved multi-family, commercial, light industrial or mixed-use buildings into separate individually owned lots.
- Section 2. Repeal and Readoption of Section 17.70.010. Section 17.70.010 is hereby repealed and readopted, as shown in Exhibit A, and incorporated herein.
- Section 3. <u>Public Inspection</u>. Copies of this Ordinance and the Gypsum Municipal Code are available for public inspection at the office of the Gypsum Town Clerk.
- Section 4. Public Hearing. A public hearing on this Ordinance shall be held on the 25th day of February, 2020 at 7:00 p.m. at the Town of Gypsum Town Hall, 50 Lundgren Boulevard, Gypsum, Colorado.
- <u>Section 5.</u> <u>Effective Date</u>. This Ordinance shall become effective as a permanent Ordinance five (5) days after publication, following final adoption after a
