## TOWN COUNCIL TOWN OF GYPSUM, STATE OF COLORADO ORDINANCE NO. 03 (SERIES 2020)

## AN ORDINANCE REPEALING AND RE-ADOPTING SECTION 18.06.010, ADOPTION OF SECTION 18.02.773 SOLAR ENERGY FLUSH ROOF MOUNTED, AND ADOPTION OF SECTION 18.02.774 SOLAR ENERGY GROUND MOUNTED, OF THE GYPSUM MUNICIPAL CODE REGARDING COMMERCIAL SOLAR INSTALLATIONS

WHEREAS, the Town of Gypsum, Colorado ("Town"), is a home rule municipality of the State of Colorado, duly organized and existing under Article XX of the Colorado Constitution and the Gypsum Home Rule Charter effective October 21, 1982; and

WHEREAS, pursuant to Article 1.3 of the Charter, the Town has all power of local self-government and home rule and all power possible for a home rule municipality to have under the Constitution and laws of the State of Colorado; and

WHEREAS, the Town Council has, by Ordinance, adopted Title 18 of the Gypsum Municipal Code ("Code") regarding the subdivision of property including design requirements; and

WHEREAS, the Town Council has determined that revising solar energy installations on certain zone districts is necessary to promote efficient design of development projects.

NOW THEREFORE, be it ordained by the Town of Gypsum, Colorado, that Section 18.06.010 of Chapter 18.06, Section 18.02.773 and Section 18.02.774 of Chapter 18.02, of the Gypsum Municipal Code are amended:

SECTION 1. Repeal and Readoption of Section 18.06.010 of the Gypsum Municipal Code. Section 18.06.010 of the Gypsum Municipal Code is hereby repealed and readopted in its entirety as set forth in Exhibit A, attached hereto and incorporated herein.

**SECTION 2.** Adoption of Section 18.02.773 of the Gypsum Municipal Code. Section 18.02.773 is hereby adopted as set forth below:

18.02.773 - Solar Energy Flush Roof Mounted.

Solar Energy Flush Roof Mounted means solar panels and appurtenances mounted on roof tops parallel to the roof top with no more than a two-foot (2') separation between the roof top and solar panels.

**SECTION 3.** Adoption of Section 18.02.774 of the Gypsum Municipal Code. Section 18.02.774 is hereby adopted as set forth below:

18.02.774 - Solar Energy Ground Mounted.

Solar Energy Ground Mounted means one or more solar panels and appurtenances mounted from the ground or other structures not considered a roof top.

**SECTION 4.** Public Inspection. Copies of this ordinance and the Gypsum Municipal Code are available for public inspection at the office of the Gypsum Town Clerk.

SECTION 5. Public Hearing. A public hearing on this Ordinance shall be held on the 25<sup>th</sup> day of February, 2020, at 7:00 p.m. at the Town of Gypsum Town Hall, 50 Lundgren Boulevard, Gypsum, Colorado.

SECTION 6. Effective Date. This Ordinance shall become effective as a permanent Ordinance five (5) days after publication, following final adoption after a public hearing held on the 25th day of February, 2020, at 7:00 p.m., at the Gypsum Town Hall, 50 Lundgren Blvd., Gypsum, Colorado.

**SECTION 7.** Severability. If any provision of this Ordinance shall be or become invalid or unenforceable, the remainder of the provisions shall not be affected thereby, and each and every provision shall be enforceable to the fullest extent permitted by law.
